THE COMMISSION'S MANDATE

The Manitoba Law Reform Commission is an independent law reform agency established by *The Law Reform Commission Act*. The Commission's duties are to inquire into and consider any matter relating to law in Manitoba with a view to making recommendations for the improvement, modernization and reform of law, including:

- the removal of provisions of the law that are outdated or inconsistent;
- the maintenance and improvement of the administration of justice;
- the review of judicial and quasi-judicial procedures under any Act;
- the development of new approaches to, and new concepts of, law in keeping with and responsive to the changing needs of society and of individual members of society; and
- any subject referred to it by the Minister.

MANDAT DE LA COMMISSION

La Commission de réforme du droit du Manitoba est un organisme indépendant du gouvernement du Manitoba, établi en vertu de la *Loi sur la Commission de réforme du droit*. - de supprimer les dispositions du droit qui sont désuètes ou incompatibles;

- d'examiner les procédures judiciaires et quasi-judiciaires prévues par une loi quelconque;
- d'élaborer de nouvelles méthodes et de nouveaux concepts de droit correspondant à l'évolution des besoins de la société et des individus qui la composent;

PART I

INTRODUCTION

The Manitoba Law Reform Commission is pleased to present its annual report for 2020-2021.

In 2020, the Commission celebrated its 50th anniversary. To mark this milestone, the Commission will begin this annual report by offering some reflections on its role in Manitoba.

Laws are reformed in a number of ways. The legislature, judges, professional organizations and community groups all help to shape the laws of a province. Law reform agencies play an important role when it comes to effecting change in the law. As the Commission previously noted:

Law Reform Commissions were established in Manitoba and elsewhere in recognition of the fact that common law and statute law have traditionally been unable to keep up fully with ever-changing social conditions. [...] Courts are only able to effect changes in the law as and when cases in troublesome areas happen to come before them; legislatures are inevitably occupied with issues having greater political interest.¹

Law reform agencies are uniquely positioned to provide non-partisan advice, arms-length from the government or economic interests. The Commission strives to perform its statutory duties with expertise, objectivity, and continuity. Over the course of its 50 years, the Commission has issued 144 reports and 45 informal reports and issue papers. Many of the Commission's recommendations have been implemented in legislation, while others have been cited in judgments, scholarly journal articles and reports from other law reform agencies.

In this 50th year of law reform in Manitoba, we celebrate the Commission's past achievements and look forward to many productive years ahead.

The Commission published two final reports in 2020-2021: *Electronic Witnessing of Affidavit Evidence* (Report #140) and *Abandoned Accounts and Missing Money: Establishing a Process for Unclaimed Intangible Property* (Report #141). The Commission currently has three projects underway: laws related to elder abuse and neglect, reforms to partition and sale legislation, and presumption of consent legislation for organ donation. The Commission expects to release consultation papers for all three projects in 2021.

2020-2021 was a year unlike any other. The COVID-19 pandemic affected every facet of our lives. The Commission's operations, including Commission meetings, moved to a virtual format. While the Commission looks forward to meeting in person once it is safe to do so, the shift to working

remotely also presented opportunities for improved efficiency. In future, the Commission will continue to employ some of the practices adopted during the pandemic, where appropriate.

In keeping with its mandate, the Commission makes recommendations that improve, clarify and update the laws of Manitoba. The Commission continues to find new ways to engage with the public and legal community, to not only consult on areas of law reform and ensure that its recommendations are practical and sensible, but also to provide public legal education on selected topics.

For a law reform agency of its size, the Commission maximizes its resources to produce meaningful publications every year and contribute to the conversation surrounding important issues affecting Manitobans.

PART II

THE YEAR IN REVIEW April 1, 2020 to March 31, 2021

1. FINAL REPORTS ISSUED

A. Electronic Witnessing of Affidavit Evidence (Final Report #140)

On August 27, 2020, the Commission released its 140th Final Report, *Electronic Witnessing of Affidavit Evidence*.

Pursuant to *The Manitoba Evidence Act*, a number of court documents require the administration of an oath, affirmation or statutory declaration. Prior to 2020, these documents had to be executed in the presence of a person qualified to administer oath, affirmation or statutory declaration as set out in the Act. This *presence* requirement has long been interpreted to require that both persons must be in each other's physical presence and that remote execution (for example, by way of videoconferencing) did not meet the requirements under the legislation. In this report, the Commission considered whether the presence requirement unduly burdens litigants residing in remote or northern communities in Manitoba. The Commission also considered whether changes to *The Manitoba Evidence Act* could eliminate that burden while still maintaining the protections currently afforded under the Act.

To carry out this project, the Commission received a special project grant from the Manitoba Law Foundation (Foundation), as the project fit with the Foundation's goal to fund projects that address access to justice for remote and northern communities.

The Commission released a consultation paper on January 8, 2020 entitled *Bridging the Gap for Remote Communities: Electronic Witnessing of Affidavit Evidence*. Following the consultation paper's release, then-Commission legal counsel Kobra Rahimi engaged in extensive consultation including travel to Thompson and The Pas to engage with legal practitioners, Elders, members of the judiciary, and community members in northern communities.

As the Commission began to consider the feedback from the consultation phase of this project in the spring of 2020, the COVID-19 pandemic necessitated immediate changes in the administration of justice. Social distancing requirements added a new and insurmountable challenge to the physical presence requirement in *The Manitoba Evidence Act*. The provincial government responded by enacting a temporary order pursuant to *The Emergency Measures Act* that would, among other things, suspend the physical presence requirement set out in *The Manitoba Evidence*

Act.

The Commission's final report, *Electronic Witnessing of Affidavit Evidence*, was released in August 2020. At the time of the report's release, the temporary order was still in effect. The report contains five recommendations for reform, including the recommendation that *The Manitoba Evidence Act* be amended to expressly enable authorized individuals to witness the swearing or affirming of affidavit evidence remotely where certain preconditions have been met. In other words, the Commission recommends that the allowance for remote execution as set out in the temporary order should be a permanent change, not simply an exception during the pandemic.

The adage that "crisis is the driver of innovation" has certainly resonated in the wake of the COVID-19 pandemic. In the fall of 2020, the provincial government introduced amendments to *The Manitoba Evidence Act* and several other statutes that would make permanent some of the changes that were brought in under temporary orders. Bill 62, *The Remote Witnessing and Commissioning Act (Various Acts Amended)*, passed on December 3, 2020. The amendments, which have not yet been proclaimed, enable the use of videoconferencing or similar technology when commissioning an oath or affirmation or when witnessing a will, power of attorney, land titles document or health care directive. The Commission welcomes these changes as they help to overcome a barrier to access to justice that had been affecting people living in remote and northern communities long before the pandemic.

B. Abandoned Accounts and Missing Money: Establishing a Process for Unclaimed Intangible Property (Final Report #141)

On January 29, 2021, the Commission released its 141st Final Report, titled *Abandoned Accounts and Missing Money: Establishing a Process for Unclaimed Intangible Property*.

In Manitoba, both escheats (which refers to the property of a person who dies without a will and has no known heirs) and unclaimed property vest in the Crown. The Commission has learned that the process for claiming escheated or unclaimed property is cumbersome for the government to administer and impractical for individuals seeking to claim the property. Some other Canadian jurisdictions have introduced legislative changes to modernize and improve legislation related to property that vests in the Crown with a number of these jurisdictions having established unclaimed property regimes. The Commission's project examines reforms in other jurisdictions and considers whether similar reforms should be adopted in Manitoba.

The Commission released a consultation paper on October 24, 2019. The Commission engaged in consultations and received valuable feedback from other Canadian jurisdictions that have implemented unclaimed property administration systems.

In the Commission's final report, released in January 2021, the Commission recommends that Manitoba establish a process for the management of unclaimed intangible personal property. The report contains twenty recommendations regarding the establishment of unclaimed property

legislation. In the Commission’s view, the main objective of such legislation should be the facilitation of a process to reunite owners with their property in a way that is efficient for the government or a third party to administer and accessible for the owners of such property to use.

2. CURRENT PROJECTS

A. Elder Abuse and Neglect

The Commission is undertaking a review of the legal landscape of elder abuse and neglect in Manitoba to consider whether the relevant laws, policies, and systems that are currently in place are sufficient to address the abuse and neglect of older adults living in the province. In order to consider these issues in an informed manner, the Commission intends to undertake this review in a series of reports, which will begin with an analysis of the current legal landscape for older adults living in the community (i.e. those not living in an institutionalized setting such as a personal care home). By beginning this series of reports with an examination of the incidence, particulars, and legal landscape of elder abuse and neglect in the community context in Manitoba, the Commission hopes to gain a clearer understanding of the laws, policies, and systems that might ultimately require reform.

The Commission formed an elder abuse project advisory committee in early 2021. The committee of experts and community leaders will help steer the project and ensure that the Commission’s recommendations are practical and meaningful for older adults living in the community. The Commission expects to release a consultation paper in the summer of 2021.

B. Presumed Consent Organ Donation

Manitoba has an “express consent” or “opt-in” framework for organ donation. Under Manitoba’s current system, Manitobans may indicate their intent to become an organ and/or tissue donor by registering their consent. Without this express indication of consent, Manitobans will not become organ or tissue donors after death.

The Commission is reviewing recent developments in other Canadian jurisdictions that are moving away from the “opt-in” model of organ donation toward a presumed consent model. Under the presumed consent model, when there is no record of a person’s decision on organ and tissue donation, the person’s consent is considered to have been given. The Commission is therefore examining the legislative considerations if Manitoba were to amend *The Human Tissue Gift Act* to implement a system of presumed consent organ donation. The Commission is not making a recommendation with respect to the question of *whether* Manitoba should adopt a presumed consent model, which is a political decision, but rather will limit the scope of this project to the various legislative changes that would be implicated if Manitoba were to move toward a presumed consent model. The Commission will release a consultation paper in May 2021.

C. The Law of Partition and Sale

The Commission has commenced a review of Manitoba's laws on partition and sale under *The Law of Property Act*. Partition and sale are statutory remedies available to co-owners of land who wish to terminate their co-ownership but cannot agree on how it should be terminated.

In light of law reform reports and developments in other Canadian jurisdictions, the Commission is considering how Manitoba's legislation could be improved. The Commission plans to release a consultation paper in the fall of 2021 on this topic.

3. UPDATE ON PREVIOUS PROJECTS

A. Interim Judicial Decisions under *The Arbitration Act*

As indicated in the 2019-2020 Annual Report, the Commission intended to examine s. 6 of *The Arbitration Act*, which provides that no court may intervene in matters governed by the Act except for specific enumerated purposes. Upon further review, the Commission determined that s. 8 of *The Arbitration Act* and case law interpreting this provision appear to address the concerns identified in the original project description. Therefore, the Commission will not be proceeding with this project.

4. FUTURE PROJECTS

The Commission follows a formal procedure for selecting topics that are appropriate for law reform projects based on a set of project selection criteria along with the Commission's mandate. This section provides an overview of projects the Commission intends to pursue in 2021-2022 in addition to the current projects presented in the previous section.

A. Administrative Tribunals Legislation

The Commission will conduct a review of legislation governing administrative tribunals and judicial review. This project was originally considered by the Commission in 2013, with a proposed project on the enactment of a provincial law to govern the procedural rights of individuals in tribunal proceedings. The Commission put the project on hold for a number of years, but has now decided to revisit the issue in light of recent legislative initiatives in other Canadian jurisdictions in the area of administrative justice reform.

The Commission plans to work closely with administrative law experts for this project, and will form a project advisory committee. Due to scope of this project, the Commission has determined that it will divide the project into a series of reports, each dealing with a separate administrative law issue. The Commission expects the work of the project advisory committee will begin in the fall of 2021.

B. The Parents' Maintenance Act

The Commission will undertake a project on updating *The Parents' Maintenance Act* with respect to the obligation of adult children to provide financial support to their parents by a court judgment. *The Parents' Maintenance Act* was enacted in 1933 during the Depression era and is largely unchanged since its enactment. The Commission will consider whether the legislation reflects current values and understandings and whether reform is required to bring the legislation in line with present day realities. The Commission will release a consultation paper in 2021-2022.

C. Anti-SLAPP Legislation

The acronym SLAPP stands for “Strategic Lawsuits Against Public Participation”. SLAPPs are used by wealthier, more powerful litigants against individuals or groups in order to intimidate, coerce, and silence participation in public debate by waging expensive legal proceedings against those individuals or groups. SLAPPs are often launched despite having no (or very little) chance of success with the purpose of exhausting the resources of critics. Anti-SLAPP legislation provides a remedy to SLAPP lawsuits. It establishes procedures that allow courts to strike out lawsuits at the outset and allow defendants to recuperate costs if certain criteria are met. Several Canadian jurisdictions have established Anti-SLAPP legislation.

For this project, the Commission will review developments in other Canadian jurisdictions and consider whether Manitoba should adopt Anti-SLAPP legislation. The Commission will begin work on this project in 2021-2022.

D. Creating Efficiencies in the Law

The Commission will continue to address relatively straightforward legislative solutions in discrete projects in its series on *Creating Efficiencies in the Law*. In its consultations with the legal profession and other organizations and members of the public, the list of projects will be added to in the future.

The Commission welcomes comments and suggestions with respect to these subject areas and any other potential law reform projects.

5. IMPACT OF COMMISSION REPORTS

The Commission is encouraged by certain legislative changes in 2020-2021. In addition to the changes to *The Manitoba Evidence Act* to allow for electronic execution, as described above, the Commission welcomes proposed changes to limitations of actions legislation in Manitoba. Bill 51, *The Limitations Act* is expected to pass in spring 2021. For a number of years, the Commission has been encouraging the provincial government to implement changes from its 2010 report (Final Report #123, *Limitations*) and the Commission is pleased to note that Manitoba will finally be amending its outdated limitations of actions legislation.

The Commission continues to urge the Minister of Justice to implement the outstanding recommendations of the Commission, many of which would lead to efficiencies in the administration of justice. In particular, the changes recommended in Final Report #136, *The Builders' Liens Act of Manitoba: A Modernized Approach*, would provide clarity and bring the legislation in line with the construction industry's practices. Further, the Commission's recommended changes to wills and succession legislation in Final Reports #108 and 139 would go a long way to updating wills legislation in Manitoba. The Commission's reports undergo a consultation process before final reports are released, so that legal practitioners and interested individuals and groups have the opportunity to provide feedback on the recommendations contained therein. This process ensures the recommendations are meaningful, practical and their implementation would improve the laws of Manitoba.

Commission reports not only impact on the law through legislative amendments; the Commission's publications have been the subject of commentary in legal journals, print and electronic media and court and tribunal judgments. The Commission has been cited in over one hundred judgments, including the Supreme Court of Canada's judgments in *A.C. v. Manitoba (Director of Child and Family Services)*, [2009] 2 S.C.R. 181; *Manitoba Métis Federation Inc. v. Canada (Attorney General)*, [2013] 1 S.C.R. 623; and *Olson Dominion Construction Ltd. v. Structal Heavy Steel*, [2015] 3 S.C.R. 127. Most recently, Final Report #100, "Class Proceedings" was referenced by the Manitoba Court of Appeal in *McLean et al. v. Canada (Attorney General)*, 2021 MBCA 15.

PART III

ADMINISTRATION

1. THE COMMISSIONERS

The Manitoba Law Reform Commission is composed of five to seven members appointed by the Lieutenant Governor in Council. Section 3 of *The Law Reform Commission Act* requires that the Commission's membership include a judge of the Court of Queen's Bench; a full-time member of the Faculty of Law, University of Manitoba; a lawyer entitled to practice in Manitoba and not in the employ of the government; and a non-lawyer. The current members of the Commission and their terms of office are as follows:

Currently, the Commission does not include a judge of the Court of Queen's Bench as Commissioner Hon. Lori Spivak was appointed to the Manitoba Court of Appeal in 2019. As she was no longer a sitting judge of the Court of Queen's Bench, Justice Spivak was not able to continue as a Commissioner of the Manitoba Law Reform Commission. The Commission is awaiting the appointment of a replacement.

The Commission held six regular meetings during the 2020-2021 fiscal year.

2. STAFF

Kristal Bayes-McDonald served as the Commission's director and legal counsel until she commenced a one-year leave in November 2020. Elizabeth McCandless returned to the Commission to serve as director and legal counsel during Ms. Bayes-McDonald's absence. Additionally, the Commission retained Stefanie Goldberg as junior legal counsel in September 2020. Linda Manson served as the Commission's administrator.

3. FINANCE

The Manitoba Law Foundation provided an annual core grant of \$115,000 to the Commission for the 2020-2021 fiscal year. Manitoba Justice continues to provide a total grant of \$100,000 consisting of in-kind services valued at \$15,000 and a monetary grant of \$85,000.

The Commission wishes to thank both Manitoba Justice and the Manitoba Law Foundation for their continued support of its work.

4. EXTERNAL RELATIONS AND ACTIVITIES

In 2020-2021, the Commission continued to work with other organizations in the community through public legal education and consultation.

The Commission is well-situated to provide educational opportunities for law students. New in 2020-2021, the Commission established an externship program through the Faculty of Law, University of Manitoba. Through the externship, one law student, Adam Lakusta, gained practical skills by working on law reform matters under the supervision of Commission staff while earning credit toward his law degree. This 12-credit hour externship replaced the former 3-credit hour internship program. The externship provided a more immersive experience for the student, while providing the Commission with valuable research contributions to law reform projects. The Commission intends to retain an extern law student once again in 2021-2022.

The Commission engaged in a project with three second and third-year law students through the Faculty of Law's Pro Bono Students Canada (PBSC) program. Commission staff created a project that was tailored to suit the educational needs of the students and provided supervision and feedback along the way. The PBSC project built upon the electronic evidence project by examining changes to court processes and the execution of documents across Canada as a result of the pandemic. The Commission is considering the results of the research and determining whether to pursue this project further.

The Commission recognizes the importance of community outreach to ensure the relevance and quality of law reform initiatives while contributing to legal education in Manitoba. In 2020-2021, the Commission participated in a number of presentations to further legal education and professional development in Winnipeg. The Commission participates in Manitoba Bar Association events to provide legal education to the legal profession. On January 21, 2021, the Commission conducted a seminar at the Manitoba Bar Association's 2021 Mid-Winter Conference on selected law reform topics. The conference took place in a virtual format in 2021, so the seminar was delivered by way of webinar. The Commission will continue to connect with the legal profession in 2021-2022 by delivering webinars as a means to provide legal education on law reform topics and to engage with members of the profession and the public on law reform initiatives.

The Commission is a member of the Federation of Law Reform Agencies of Canada (FOLRAC) and the Commonwealth Association of Law Reform Agencies. Commission staff share ideas and learn from the experience of other FOLRAC members through regular teleconferences and symposiums. In the past year, there has been a growing recognition of the importance of independent law reform agencies in Canada. The Institut Québécois de réforme du droit et de la justice was established in Quebec. In the spring of 2021, the federal government announced its intention to revive the Law Commission of Canada. The Commission welcomes these developments and looks forward to working with these new law reform agencies in the future.

Commission staff and former Commissioner Hon. Gerald Jewers act as the Commission's representatives with the Access to Justice Stakeholders Committee, created by the Law Society of Manitoba in 2011. Representatives of government, the courts, the practicing bar and legal aid bodies are also included in the Committee. The purpose of the Committee is to share ideas, information and best practices and to coordinate efforts in the area of access to justice.

PART IV

CONCLUSION

The Commission again wishes to express its gratitude to the Manitoba Law Foundation and Manitoba Justice for their continued support.

Thank you also to the staff of Manitoba Justice, the Faculty of Law, University of Manitoba, Provincial Archives and Legislative libraries for their continued assistance over the past year.

The Commission is grateful for the assistance of Ms. Charlotte Price, Director of Manitoba Justice - Civil Legal Services in providing a liaison between the Commission and the Minister. Finally, the Commission thanks the Minister of Justice and Attorney General, the Hon. Cameron Friesen.
